

'Lockdown' (Covid-19) photography competition

Terms and conditions

You must be aged 16 or over and living in the Midlands.

You must state on the form if you are a professional photographer. The competition is open to any member of the public irrespective of experience.

Employees and directors of associated companies, including sponsors, cannot enter.

Judges are not permitted to enter the competition.

Each entrant may submit up to 4 photographs.

The deadline for all entries is 31st May 2020.

Announcements of winners and honourable winners of all forms will be published online after 31st May 2020. Details on the exhibition and gallery will be made in due course depending on lockdown restrictions being lifted and further government rules on social distancing.

The decision of the Creatives We Are judging panel for the competition at all stages is final.

By entering the Competition, you agree to Creatives We Are and associated companies receiving and holding your registration data in accordance with GDPR rules and guidelines. This data will be used to contact you with further information on this competition and other news from Creatives We Are associated companies.

During all stages of the competition, details of winners and honourable winners of all forms will be published online on social media channels operated by Creatives We Are and associated companies.

Only photographs will be accepted as entries. This includes photography taken on your phone or camera. Toned images (e.g. sepia, selenium, etc) will also be accepted. Images may be captured using film or digital devices.
